GUARANTEE CONDITIONS

Estil Gurú, S.L. guarantees that the WATER-STOP waterproofing membrane meet the technical specifications and quality standards that apply to them, specifically those derived from the UNE EN Norm 13956.

Estil Gurú, S.L. guarantees for 10 years, guarantees for a period of 10 years, from the date of the original purchase invoice issued to the storekeeper, that its WATER-STOP MEMBRANE, AIKIT and EVOLUX waterproofing systems are free of any defect in their materials or their manufacture that prevent their normal operation in correct conditions of transport, storage, use, installation and maintenance.

In order for the guarantee provided by this certificate to be fully valid, it will be necessary for the installation of the waterproofing systems to be carried out in accordance with the specifications detailed in the INSTALLATION GUIDE that is attached as an attached document.

EXCLUSIONS AND LIMITATIONS OF GUARANTEES

This guaranty is limited to protecting retail sales made by the authorized dealer by Estil Guru, S.L.

The guarantee may be claimed during the established period of validity and immediately upon detection, unless they are visible defects, in which case the claim must be made within a period of two months from the date of delivery. of the buyer and always before installation.

In general, will be exempt from the guarantee rights the damages and malfunctions of the waterproofing systems that have their origin in:

- Accidents or negligent, improper or inadequate use.
- Do not respect the instructions for installation, use and maintenance established in the INSTALLATION GUIDE provided by Estil Gurú, S.L.
- Damage suffered by the surface on which the waterproofing systems are applied as a result of third-parts actions, earthquakes or any other causes of force majeure other than the normal use conditions of the product and control of Estil Gurú, S.L.

CLAIM OF GUARANTEE RIGHTS

- 1) Inform immediately and in writing.
 - o To the company that sold you the waterproofing system.

The communication must be accompanied by a copy of the proof of purchase of the waterproofing material object of the claim in which the date of acquisition appears.

- 2) Received said claim in Estil Gurú, S.L. the After Sales Service Department will proceed to its analysis, resolving its origin or not, justifiably under the provisions of this limited warranty document, and informing them of the client and the instructions to follow. In any case, the mechanics of the procedure to be followed will be:
 - o With the invoice provided by the claimant, the point of sale will be verified so that the authorized distributor that has sold the material physically verifies that the claim object has been caused as a result of a system defect.
 - o In case of positive verification by the authorized distributor, the supplier, Estil Gurú, S.L. It will send its own technician who, after the pertinent inspection, will open the corresponding part of the accident, informing the insurance company as soon as possible.

Estil Gurú, S.L. won't respond to claims when the authorized distributor is not up-to-date on their payments with Estil Gurú, S.L.
